Project Outline

Moving On is a partnership between Tees Valley Arts and the five boroughs of the Tees Valley (Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton) working with young people who are in the care of the local authority. It is a creative project, using the arts to give the young people a range of skills to help them to move on positively, adding value to the dedicated work of the Care Teams to:

- develop creative skills
- support enjoyment and cultural engagement/ entitlement
- build confidence and self-esteem
- develop communication skills
- develop teamwork and leadership
- achieve a qualification (Bronze Arts Award Level 1).

Please note that visiting sessional artists will run the creative activities.

Role of Host Artist Worker

The Host Artist Worker will assist the visiting artists in activities, and will lead on the Arts Award element of the project – ensuring that portfolios are completed and all aspects of Bronze Arts Award have been fulfilled. Applicants must have significant experience and/or knowledge of youth work, preferably with hard to engage or challenging young people and must be a trained Arts Award adviser, having successfully run Arts Award with other groups. If you are not already trained but are interested in delivering Arts Award and are prepared to undertake training, we would be happy to discuss this further.

- Your experience/ knowledge/ understanding of Arts Award
- How you would address travel and transport to sessions
